

5 Days of Santa Fe Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Contest is open only to those who enter according to the rules and who are 18 years of age or older as of the date of entry. The Contest is only open to legal residents of the United States and is void where prohibited by law. With the exception of students who are participating in the College's work study program, employees of Santa Fe College in Gainesville FL, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Santa Fe College as final and binding as it relates to the content of this Contest.
3. **Contest Period:** Entries will be accepted online starting on 12/05/16, 12:00 a.m. EST, and ending 12/09/16, 11:59 p.m. EST. Daily online entries must be received by 11:59 p.m. EST. on day of specific theme.
4. **How to Enter:** The Contest must be entered by submitting a photograph/post/share according to the daily instructions posted online at <http://www.sfcollege.edu/countdown>. The entry must fulfill all Contest requirements, as specified daily, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Santa Fe College. You may enter only once per day, per round. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Santa Fe College.
5. **Prizes:** The Winner(s) of the Contest (the "Winner") will receive a Santa Fe swag pack with the approximate value of \$25 USD. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by Santa Fe College. No cash or other prize substitution shall be permitted except at Santa Fe College's discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Santa Fe College to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
6. **Odds:** The odds of winning depend on the number of eligible entries received.
7. **Winner Selection and Notification:** Winner will be selected by Santa Fe College. Winner will be notified by private message on Facebook within five (5) days following selection of Winner. Santa Fe College shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within thirty (30) days from the time award notification was sent, or fails to timely return

a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner may be selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. By entering this content, You represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of Santa Fe College. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. Terms & Conditions: Santa Fe College reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Santa Fe College's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, Santa Fe College may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Santa Fe College. Santa Fe College reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. Santa Fe College has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws. Should such attempt be made, Santa Fe College reserves the right to seek damages to the fullest extent permitted by law.
