Proof of Eligibility

You can use **one** of the following items for proof of eligibility, as applicable. Be sure to write your Sprint wireless number on each page you fax to Sprint.

- Current company/university/organization identification
- Current membership card with your name and member ID (Note: Membership card cannot be handwritten.)
- Unexpired Credit Union debit / credit card
- Recent pay or pension stub issued within the last 90 days
- Current statement of account issued within the last 90 days
- Veteran ID card, Department of Defense form 214, copy of military orders, expired military ID or military W-2 (Note: The Department of Defense does not permit active military IDs to be photocopied, scanned or faxed as a proof document.)

Cover, delete or black out all sensitive information such as Social Security number, financial institution account numbers, credit card numbers and salary details. Write your Sprint phone number on every page of your documentation. Sprint is not liable for confidential information.

Business cards or letterhead are not acceptable items for showing eligibility.

If you have an email address issued by the company, university or organization that you're asking for a discount through, please visit sprint.com/verify within 30 days and follow instructions there to lock in your discount. This is Sprint's preferred method. With this email address, there is no need to fill out this form.

If you don't have an email address issued by the company, university or organization you're asking for a discount through, please complete these important steps to submit proof of eligibility online or by fax.

1. Confirm your discount eligibility by uploading or faxing proof of your active status as an employee, student or member.

Submit a copy within 30 days of **one** of the following items that clearly shows your name and the name of your company/ university/organization and any applicable dates. **Write your Sprint wireless number on each page you fax to Sprint.**

Cover, delete or black out all sensitive information, such as Social Security number, financial institution account numbers, credit card numbers and salary detail. Sprint is not liable for confidential information.

Check the item you will be submitting below:

- Current company/university/organization identification
- Current membership card with your name and member ID (Note: Membership card cannot be handwritten.)
- Unexpired Credit Union debit/credit card
- Recent pay or pension stub issued within the last 90 days
- Current statement of account issued within the last 90 days
- Veteran ID card, Department of Defense form 214, copy of military orders, military W-2 or expired military ID (Note: The Department of the Defense does not permit active military IDs to be photocopied, scanned or faxed as a proof document.)

Business cards or letterhead are not acceptable items for showing eligibility.

Failure to demonstrate eligibility for your company/university/organization may result in charges for benefits you are not eligible to receive. Once we validate your information, the discount will appear on your invoice in 1 to 2 billing cycles. If you provided a valid email address you will receive a confirmation email from us.

You will not be considered affiliated with your company's, university's or organization's account or Service Agreement and will not receive any service plan discounts until Sprint receives and validates your Sprint Discount Program Eligibility Verification Form and proof of eligibility. Please direct questions about your discount eligibility to your company, university or organization. Sprint is unable to issue retroactive credits.
